**WHEREAS** pursuant to the terms of the Initial Order, KPMG Inc. (the "**Monitor**") was named Monitor of the Applicant;

**WHEREAS** on November 27, 2015, the Court issued a Sanction Order (the "**Order**") sanctioning the Re-Amended Plan of Compromise and Arrangement filed by the Applicant (the "**Plan**");


**WHEREAS** capitalized terms found herein shall have the same meaning ascribed thereto in the Plan; and

**WHEREAS** the Plan provides that upon the occurrence and/or fulfillment of all of the Plan Implementation Conditions (or waiver thereof, as the case may be) on or prior to December 18, 2015 or such later date as may be ordered by the Court, the Monitor shall issue and file with the Court a certificate to such effect (the "**Certificate of Implementation**").

**THE MONITOR HAS DETERMINED** that all of the Plan Implementation Conditions have occurred, been fulfilled, or been waived on or prior to December 18, 2015, and the Monitor hereby signs and will file the present Certificate of Implementation with the Court.

This Certificate of Implementation is issued by the Monitor at 11:30 AM on **November 30, 2015**.
