1. An Order substantially in the form of Schedule "A", attached hereto:

- (a) if necessary, abridging the time for service of this Application and supporting Reports (the "Reports") of KPMG Inc. ("KPMG") in its capacity as the proposed receiver and manager (in such capacity, the "Proposed Receiver") of the assets, properties and undertakings of Bearstone Environmental Solutions Inc. ("Bearstone") and declaring service to be good and sufficient; and
- (b) sealing the First and Second Confidential Supplement to the Reports (collectively, the "Confidential Supplements").
- 2. Such further and other relief as this Honourable Court deems just.

Grounds for making this application:

Background

- 3. Pursuant to applications filed by Nations Fund I, LLC, ("Nations") returnable August 6, 2019, Nations is seeking (among other things) orders:
 - (a) appointing the Proposed Receiver as receiver and manager of the current and future assets, undertakings and properties of Bearstone; and
 - (b) approving the adoption and acceptance by KPMG in its capacity as receiver and manager, and not in its personal capacity, of the Amended and Restated Asset Purchase Agreement (the "APA") entered into between Bearstone (as vendor), Silverpoint Energy Services Inc. (as purchaser), New West Energy Services Inc. (as guarantor) and Nations (as lender).
- 4. In anticipation of the appointment of the Proposed Receiver as receiver and manager and the adoption and acceptance by the Proposed Receiver of the APA, the Proposed Receiver prepared the Reports and Confidential Supplements.

Sealing Order

- 5. The Confidential Supplements contain an appraisal outlining the liquidation value of the assets that are subject to the APA.
- 6. A sealing order directing the sealing of the Confidential Supplements is necessary due to the risk that the public disclosure of the contents of the appraisal contained therein may

prejudice a future sales process in the event that the transaction contemplated under the APA is not approved by this Honourable Court or does not close. There are no reasonable alternative measures, and the benefits of a sealing order would outweigh any negative effects on the interests of the public.

7. The Proposed Receiver is seeking the sealing of the Confidential Supplements until such time as the transaction contemplated by the APA has closed.
