Please take notice that on May 3, 2019, the Commercial Division of the Superior Court of Québec, District of Montreal (the "**Court**"), issued an order (the "**Liquidation Order**"), in the court file bearing number 500-11-056442-193 in relation to the Debtors. As per the terms of the Liquidation Order, KPMG Inc. was appointed liquidator (the "**Liquidator**") of the Debtors to perform the distribution of their assets and the settlement of their debts.

Also, please take notice that on May 3, 2019, the Court also issued an order (the "**Claims Process Order**"), under the court number 500-11-056442-193. The Claims Process Order relates to the Debtors, their directors and their officers. It provides for a process (the "**Claims Process**") for the purposes of identifying, establishing, adjudicating or otherwise resolving any and all Claims (as defined in the Claims Process Order) against the Debtors. The Claims Process will be conducted by the Liquidator.

Any person who believes that they it may have a Claim against the Debtors, their directors or their officers must submit a proof of claim form to the Liquidator by no later than 5:00 p.m. (Eastern time) on August 26, 2019, or any other date ordered by the Court (the "Claims Bar Date").
