Hello:

As you may be aware, on July 31, 2020, the Québec Superior Court ("**Court**") granted an order concerning **Laura's Shoppe (P.V.) / Magasin Laura (P.V.) Inc.** under the *Companies' Creditors Arrangement Act* ("**CCAA**"). KPMG Inc. was appointed Monitor of the Company.

On August 28, 2020, the Court granted a claim procedure order. You should have received by mail a correspondence from KPMG including the Proof of Claim Form (regular) as well as a personal Statement of Accounts produced by the Company.

On September 25, 2020, the Court granted an order appointing KPMG Inc. as Receiver. The sole purpose of this appointment is to allow employees of the Company whose employment was terminated during CCAA proceedings to receive eligible amounts in accordance with the *Wage Earner Protection Program Act*.

On October 23, 2020, the Court granted an order extending the stay of proceedings and granting other relief. This order authorizes the Monitor to accept and consider any proofs of claims filed by employees of the Company after the Claims Bar Date of the October 5, 2020 at 5:00 p.m. (*Caution: Other conditions also apply. See Paragraph 9 of the order*)

We invite you to complete the Proof of Claim Form (regular) and return it to KPMG with a copy of the statement of accounts as soon as possible.

– IMPORTANT –

As a former employee of the Company and as part of the ongoing process, you may be eligible for the Wage Earner Protection Program ("**WEPP**"). Please find enclosed a pamphlet concerning the *Wage Earner Protection Program Act* prepared by Human Resources and Skills Development Canada.

1. You must have transmitted your proof of claim ***duly completed and signed*** to KPMG with your Statement of Accounts before applying to WEPP.
2. You must register to the WEPP.

A PROGRAM TO PROTECT WORKER'S WAGES!

What is it?

The Wage Earner Protection Program (WEPP) is a Government of Canada program that provides timely payment of eligible wages owing to workers whose employer has gone bankrupt or become subject to receivership. Eligible wages under the Program include salaries, commissions and vacation, termination and severance pay.

Who is eligible?

Any worker who meets all of the following criteria can apply:

- your employment has ended;
- your former employer is declared bankrupt or is subject to a receivership; and
- your former employer owes you:
- wages and vacation pay earned during the six-month period ending on the date of the bankruptcy or receivership*; and/or
- termination or severance pay for employment that ended during the six-month period ending on the date of the bankruptcy or receivership.*

How does it work?

- When your former employer formally declares bankruptcy or becomes subject to receivership under the *Bankruptcy and Insolvency Act*, a licensed trustee or receiver will be appointed to administer the bankruptcy or receivership.
- The trustee or receiver assigned to administer the bankruptcy or receivership will provide you with information on the Program and on any amounts you are owed.
- You should file a proof of claim with the trustee or receiver as soon as possible. A proof of claim is a written statement you submit indicating the amount you are owed. The trustee or receiver can help you complete the proof of claim statement.
- You must then submit your application for payment to Service Canada by completing the application form found on the Service Canada website. If you do not wish to apply online, you can obtain a paper application form at your nearest Service Canada Centre.

** If your former employer went through restructuring before declaring bankruptcy or going under receivership, the eligibility period in which the amounts must be earned and in which employment has to end starts six months before the restructuring event and ends on the date of bankruptcy or receivership. For the purposes of the WEPP, a restructuring event is a proposal under Division I of Part III of the Bankruptcy and Insolvency Act or proceedings under the Companies' Creditors Arrangement Act.*



Trustees and receivers are obligated to:

- identify workers who are owed eligible wages;
- determine the amounts owed to workers;
- inform workers of the existence of the WEPP; and
- provide Service Canada and applicants with information necessary to establish eligibility for payment.

Applications must be submitted to Service Canada within 56 days from either the date of bankruptcy or receivership or the date your employment ended. Extensions may be granted if circumstances beyond your control prevent you from filing within the prescribed time frame. A written explanation for the delay must be provided.

How much will I receive?

The maximum amount you can receive under the Program is an amount equalling seven weeks' maximum insurable earnings under the *Employment Insurance Act*, less amounts that are prescribed by WEPP regulations.
