1. 2478658 Ontario Ltd. ("**247 Ontario**") filed an assignment on the 28th day of June, 2022 and the undersigned, KPMG Inc., was appointed as trustee of the estate of the bankrupt by the official receiver, subject to affirmation by the creditors of the trustee's appointment or substitution of another trustee by the creditors.
2. 100 Colborne Holdings Inc. ("**100 Colborne**") and 240 Penetanguish Holdings Inc. ("**240 Penetang**", and collectively with 100 Colborne and 247 Ontario, "**100 Colborne et. al.**"), also filed assignments on the 28th day of June, 2022, and KPMG Inc. was appointed as trustee of these bankrupt estates by the official receiver, subject to affirmation by the creditors of the trustee's appointment or substitution of another trustee by the creditors
3. Pursuant to an Order of the Ontario Superior Court of Justice [Commercial List] dated May 24, 2022, the trustee is authorized to carry out its administrative duties and responsibilities as if the bankruptcy proceedings of 100 Colborne et. al. were a single proceeding under the *Bankruptcy and Insolvency Act* (Canada). As such, the first meeting of creditors in the 247 Ontario proceedings will be consolidated with the first meetings of creditors of the 100 Colborne proceedings and the 240 Penetang proceedings.
4. The first meeting of creditors of 100 Colborne et. al. will be held on the 14th day of July 2022 at 11:00 AM at Virtual Meeting or Conference ID: 646205640#, 647-794-1236.
5. To be entitled to vote at the meeting, a creditor must lodge with the trustee, before the meeting, a proof of claim and, where necessary, a proxy.

7. Creditors must prove their claims against the estate of the bankrupt in order to share in any distribution of the proceeds realized from the Estate.


