We welcome the Government's announcement of additional financial relief for impacted businesses affected by the Omicron outbreak with:

- a new COVID support payment of NZ\$4,000 per business plus NZ\$400 per full time employee up to 50 full time employees (i.e. capped at NZ\$24,000) if they have suffered a 40% revenue reduction; and
- an extension of the Small Business Cashflow Loan Scheme to allow firms a further "top up" loan of NZ\$10,000

While the new COVID Protection Framework does allow a greater range of businesses to operate (albeit with some restrictions), the Red Traffic Light setting has had a disproportionate impact on certain sectors such as hospitality.

Income insurance scheme proposed

The Government is consulting on an income insurance scheme for New Zealanders, including its detailed design. Developed jointly by a Working Group comprising Government Officials, Business New Zealand and the Council of Trade Unions, it follows a Budget 2021 pledge to consider such a scheme, particularly considering the economic impacts of COVID.

We strongly encourage clients to engage in the upcoming consultation process. Our latest Taxmail summarises the key features of the scheme.

Tax administration in a digital world

Inland Revenue's latest consultation document looks at what the tax system's operation might look like in a fully digital world, and what it could mean for taxpayers, external parties and intermediaries (including tax advisors) and Inland Revenue.

It envisages a future state where businesses are connected to their suppliers and customers digitally, tax is integrated into businesses "natural" systems and processes, and data is exchanged in real time. This presents opportunities (tax obligations to be increasingly automated and a by-product of non-tax processes) as well as challenges (defining the role of different intermediaries and their rights and obligations as well as how to prevent digital exclusion).
