

How will the money be allocated?

The Board of Directors of the Foundation, in consultation with a Staff Advisory Committee, will allocate funds to projects which fulfill at least one of the four main focus areas listed overleaf. Only projects meeting such criteria will be eligible for funding.

- **Projects in Luxembourg and the "Grande Region"**, related to the above objectives, and/or fostering the skills and potential of young people and strengthening community cohesion.
