How do we process your personal data?

Processing of your personal data can be manual or automated, when your personal data is processed in our information systems or information systems of our Processors.

On behalf of KPMG member firms your personal data is processed only by selected employees. In this relation we take care that only trained and selected employees have access to your personal data and they fulfil obligations of confidentiality in relation to all the data (personal or other) that they learned during the performance of their work.

Personal data are not subject to automated individual decision-making, including profiling, referred to in Article 22(1) and (4) GDPR.

What are your rights in the data protection area?

Under relevant data protection legislation, you have a right to:

- information about the processing of your personal data;
- access to your personal data, including the right to obtain a copy of your personal data processed by us;
- rectification of your wrong, inaccurate or outdated personal data. When accuracy of your data is
 questionable you can request restriction of its processing until we will be able to check its accuracy;
- portability of the data which you have provided to us, in structured, commonly used and machinereadable format, and which are processed based on your consent by automated means; you have the right to transmit those data to another Controller (if such transfer is technically feasible);
- restriction of processing of personal data under condition that personal data will be stored but not processed;
- right erasure ('right to be forgotten') of your personal data in cases specifically allowed by data protection legislation, e.g.:
 - your personal data are no longer necessary in relation to the purposes for which they were collected or otherwise processed;
 - you object processing of your personal data to direct marketing purposes;
- if you provided a consent with processing of your personal data, you can withdraw it at any time by disabling of the respective tools and services used by this web site for collecting personal data for the purpose of web site visitor behavior analysis, marketing campaign optimization and advertisement personalization. The disabling of the respective tools and services might be basically done in three different ways: (1) XXXXXXXXXXXX, or (2) by disabling the use of the cookies in the respective web browser, or (3) by the use of procedures developed by the providers of analytics tools and services, or (4) by using on-line platform dedicated to managing personalized advertisement preferences.

1. Changing the options in the Privacy Preferences Center

You can change the settings of the cookies you have agreed to by clicking on the link "Cookie Settings" link located at the bottom of the website. After clicking on the mentioned link, the Privacy Preferences Center will be displayed, by turning on or off button for each of the categories of cookies, you can change the current settings of your given consent to the storage of cookie files on your device, including partial or total withdrawal of this consent.

2. Disabling the use of the cookies in the web browser

What is your right to object?

You have right to object any time to the processing of your personal data, which is performed on the basis of our legitimate interest. Objection could be lodged to our Data Protection Officer personally or by using any of our listed contacts. When you rise such objection, we will stop processing your personal data for this purpose.
