個人所得稅海外強制社會保險扣除規定

2023年12月29日稅務總局 (the General Department of Taxation; GDT) 發布第6002/TCT-DNNCN號公函,認為外籍人士根據公司內部轉調計劃在越南工作時,收到越南和海外實體所支付之所得,且該海外所得 (包括海外提撥強制保險) 隨後由越南實體全額報銷時,任何在海外提撥之強制保險在計算越南個人稅 (PIT) 時不允許扣除。

在審核企業對於GDT第6002號公函意見之解釋後,GDT於2024年2月27日透過第684/TCT-DNNCN號公函 (第 684號公函) 做出回應。據此,外籍人士具越南稅務居民身分,透過公司內部轉調計畫在越南工作,取得海外支付之薪資及工資所得,根據該外籍人士持有之國籍,依該國法律規定提撥強制保險,且該強制保險類似根據越南法律規定者,此類保險提撥在計算越南PIT時得以扣除。第684號公函並未提及越南實體與海外實體之間相關費用報銷要素。因此,聘僱成本 (包括海外提撥強制保險) 之報銷不影響所得併入越南個人所得稅中計算扣除該費用。

GDT 在第 684號公函中提出之意見是適當的,及時發布該公函係為準備個人所得年度結算申報。 企業和個人請參閱該公函規定。倘您需要就上述事項進一步說明,請聯絡KPMG以獲取更多資訊和 協助。
