## Canada to Drop Travel Mask Mandate and Entry Restrictions on Oct. 1

Sean Fraser, the Canadian Immigration Minister announced a new pathway for conversion of temporary visas to permanent residence permits for foreign workers and international students with significant work experience. The measure aims to address labor shortages in the country. Read more.

New Zealand announced the launch of the Active Investor Plus category visa for high-value investors. The minimum investment requirement to qualify for the same US\$ 5 million. Read more

South Korea on Sept. 29

The Taiwanese Ministry of Foreign Affairs announced the restoration of visa free entry for 11 countries out of 12 from 29 September 2022. These that were previously excluded from the visa exemption policy due to the COVID-19 pandemic. Read more

## Iceland restricts the issuance of residence cards

The government of Iceland announced the restriction of issuance of residence cards to foreign nationals until 2023. Instead of a residence cards, applicants will now receive a letter confirming their residence permit. Read more

Indian Students Must Submit APS Certificates With Their Visa Applications Beginning November 1

The German Missions in India announced that applicants to the student visa for Germany would have to get their academic records assessed by the Academic Evaluation Center (APS) and obtain APS certificates before filling their visa application. Read more

Poland

From 22 September, 2022, citizens of Belarus and Ukraine residing in Poland can submit applications for national visas online once the authorities begin the registration process for the same. Read more
