INSTRUCTION LETTER FOR THE PRINCIPAL OFFICERS CLAIMS PROCEDURE OF MAPLE BANK GmbH, TORONTO BRANCH

(also known as Maple Bank – Toronto Branch) (hereinafter referred to as "Maple Bank")

A. PRINCIPAL OFFICERS CLAIMS PROCEDURE

By Order of the Superior Court of Justice of Ontario [Commercial List] made January 27, 2017, under the Winding-Up and Restructuring Act (the "WURA"), KPMG Inc. in its capacity as court-appointed liquidator of the business in Canada of Maple Bank and its assets as defined in section 618 of the Bank Act (the "Liquidator") has been authorized to conduct a call for claims against the Principal Officers of Maple Bank, Toronto Branch (the "Toronto Branch") under the WURA (the "Principal Officers Claims Procedure").

The Principal Officers Claims Procedure is intended for any person who may have a claim of any kind or nature whatsoever (a "Claimant"), against any individual who is or has been a Principal Officer of the Toronto Branch and that relates to amounts for which such individual may in law be liable to pay in his or her capacity as Principal Officer of the Toronto Branch and that arose prior to February 16, 2016 (the "Winding-Up Date"), including, without limitation, any Claims arising in such individual's capacity as an officer and/or director of Maple Financial Group Inc., Maple Futures Corp., Maple Holdings Canada Limited, Maple Securities Canada Limited, Maple Trade Finance Inc., Maple Securities U.S.A. Inc., Maple Arbitrage Inc., Maple Trade Finance Corp, Maple Commercial Finance Corp, and Maple Partners America Inc. (each, an "Affiliate" and collectively the "Affiliates") to the extent that such individual served in such role in his or her capacity as Principal Officer of the Toronto Branch (collectively, the "Principal Officers Claims"). Please review the enclosed material for the complete definition of Principal Officers Claims.

B. CLAIMANTS SUBMITTING A PRINCIPAL OFFICERS PROOF OF CLAIM

If you believe that you have a Principal Officers Claim, you are required to file a Principal Officers Proof of Claim with the Liquidator. It is important that the Proof of Claim form be correctly completed and delivered to the Liquidator by 4:00 p.m. (Eastern Time) on FEBRUARY 28, 2017. The following points are set out to assist you:

- (a) The Principal Officers Proof of Claim form must be completed in its entirety;
- (b) Ensure that you include your complete name and address where all notices or correspondence regarding your claim are to be forwarded;
- (c) If the form is completed by some person on behalf of the Claimant, that person must state

his or her authority and the capacity in which he or she is acting;

- (d) You are required to provide a calculation of the claim and all supporting documentation
- (e) The amount of your Principal Officers Claim should be calculated up to the Winding-Up Date;
- (f) In Section D chose the Affiliate(s) to which your Principal Officer Claim relates;
- (g) In Section E chose the appropriate subsection(s) (i), (ii), (iii), (iv), or (v) which properly applies to the status of your Principal Officers Claim;
- (h) Ensure the form is dated, witnessed and signed in the appropriate places;
- (i) Mail the completed Principal Officer Proof of Claim form together with Schedule A to:
