AFFIDAVIT OF GALE RUBENSTEIN (Sworn December 7, 2006)

I, GALE RUBENSTEIN, of the City of Toronto, in the Province of Ontario MAKE OATH AND SAY AS FOLLOWS:

- 1. I am a partner with the law firm of Goodmans LLP ("Goodmans"), counsel for KPMG Inc. in its capacity as liquidator (the "Liquidator") of Reliance Insurance Company Canadian Branch. As such, I have knowledge of the matters hereinafter deposed to, except where stated to be on information and belief and whereso stated I verily believe it to be true.
- 2. Attached hereto and marked as Exhibit "A" to this my Affidavit is a summary invoice rendered by Goodmans to the Liquidator in respect of these proceedings for the period

October 1, 2005 to September 30, 2006 (the "Four Quarters"). Goodmans charged total fees of \$184,933.00 plus GST for the Four Quarters.

- 3. As shown by the summary of hours and hourly rates for the Four Quarters, attached as Exhibit "B" hereto, lawyers and staff at Goodmans have expended a total of approximately 495.8 hours in connection with this matter during the Four Quarters, allocated approximately as outlined in Exhibit "B".
- 4. At the commencement of the liquidation, Goodmans agreed to a discount from its then current market rates of approximately 15% to 20%, with rates not to be increased for one year. In fact, rates were not increased for the first two years of the liquidation, but were raised by 4.79%, effective October 1, 2003, reflecting the change in the Consumer Price Index over the two-year period. The discount from current market rates is approximately 20% to 30%.
- 5. Attached hereto and marked as Exhibit "C" is a description of the areas of concentration of each of Goodmans' personnel who dedicated more than 30 hours to the estate.
- 6. This Affidavit is sworn in connection with a motion by the Liquidator for, among other things, the approval of the fees and disbursements of the Liquidator and of its counsel, Goodmans, and for no improper purpose.
