UPON THE APPLICATION of KMPG Inc., in its capacity as the Court-appointed receiver and manager (the “**Receiver**”) of certain of the assets, undertakings and properties of Strategic Oil & Gas Ltd. and Strategic Transmission Ltd. (together, the “**Debtors**”) for an Order for, amongst other things, the final distribution of proceeds, approval of the Receiver’s fees and disbursements, approval of the Receiver’s activities and partial discharge of the Receiver; **AND UPON HAVING READ** the Receivership Order dated January 28, 2020, the Receivership Order - Northwest Territories Assets, also dated January 28, 2020 (the “**NWT Receivership Order**”), the third report of the Receiver dated

and filed November 2, 2020 (the “**Third Report**”), and the Affidavit of Service, to be filed (the “**Affidavit of Service**”); **AND UPON HEARING** the submissions of counsel for the Receiver, counsel for GMT Capital Corp., the Alberta Energy Regulator (the “**AER**”), the Government of the Northwest Territories (the “**GNWT**”), the Office of the Regulator of Oil and Gas Operations (“**OROGO**”), the Court-appointed Receiver of the Debtors’ assets situated in the Northwest Territories (the “**NWT Receiver**”) and from any other interested parties who may be present, with no one appearing for any other person on the service list, although properly served as appears from the Affidavit of Service;

IT IS HEREBY ORDERED AND DECLARED THAT:

SERVICE

1. Service of notice of this Application and supporting materials is hereby declared to be good and sufficient, and no other person is required to have been served with notice of this Application, and time for service of this Application is abridged to that actually given.

DISTRIBUTION OF FUNDS

2. The Receiver is authorized and directed to make a final distribution of funds as proposed in the Third Report. The estimated final cash disbursements are set forth in the following table:

Following the above distribution, the remaining funds realized in the course of its administration of the Debtors’ receivership estate (the “**Remaining Funds**”) shall be held in trust by the Receiver, pending resolution of the competing claims to the Remaining Funds among the Canada Energy Regulator (“**CER**”), AER and GNWT and/or OROGO (the “**Claimants**”). For certainty, the Remaining Funds will not be used for operational matters, including, without limitation, operational costs, professional fees (including, all fees and costs of the NWT Receiver) or other expenses related (directly or indirectly) to the assets in Alberta or the Northwest Territories except by agreement of the Claimants, or further order of this court. The Receiver shall not, subject to Paragraph 3 below, make any distributions of the

Remaining Funds unless and until agreement for their distribution is reached as between the CER, AER and OROGO, or upon the granting of a further Court Order.

3. For certainty, the Receiver will also hold back \$100,000 for the payment of the Receiver's fees and costs (including, without limitation, the Receiver's legal counsel's fees and disbursements), which is intended to cover such fees and costs in the event that, the Receiver in their role as court officer, is required to: (a) take part in future discussions and/or court proceedings related to the competing claims over the Remaining Funds and/or the Allocation Matter, and/or (b) maintain the receivership estate (including, without limitation, filing annual reports as required pursuant to the *Bankruptcy and Insolvency Act*, RSC, 1985, c B-3 and/or annual returns to prevent the Debtors from being struck from the Corporate Registry or otherwise) (the "**Professional Fees**"). The Receiver is hereby authorized to pay its and its legal counsel's Professional Fees, up to a maximum of \$100,000.

PARTIAL DISCHARGE OF THE RECEIVER

4. The partial discharge of the Receiver, as at the date of this Order, from and over all of the Property (as defined in the Receivership Order) not sold during the Receivership Proceedings, including, for certainty, those assets included in Schedule "A" to this Order, is hereby approved. For certainty, the Receiver, in its role as court officer, will, if required take part in future discussions and/or court proceedings related to the competing claims over the Remaining Funds, however, the Receiver is otherwise fully and irrevocably released of any obligations and liabilities whatsoever related to the Property not sold pursuant to the Receivership Proceedings. For certainty, the Receiver will not be discharged in its role as court officer in connection with the Remaining Funds and the Allocation Matter (as defined below), until such matters have been resolved and/or otherwise dealt with.
5. Prior to the Receiver's destruction of any of the Debtors' remaining books and records (the "**Records**"), the Receiver shall give a cumulative 30 days' notice to each of the NWT Receiver and the Debtors' former directors and officers as follows:
 - (a) The Receiver shall give 15 days' notice first to the NWT Receiver of its intention to destroy the Records. The NWT Receiver shall then have 15 days to make appropriate arrangements with the Receiver to physically take possession of the Records, at its sole cost and expense.
 - (b) In the event the NWT Receiver does not exercise its option to obtain the Records in accordance with paragraph 3(a) of this Order, the Receiver shall then give 15 days' notice to the Debtors' former directors and officers of its intention to destroy the Records. A former director and officer shall then have 15 days to make appropriate arrangements with the Receiver to physically take possession of the Records, at its sole cost and expense.

In the event that neither the NWT Receiver nor a former director and officer exercises their respective option to obtain the Records, the Receiver is hereby authorized to have all of the Records destroyed 30 days after giving notice as set-out above.

6. The Receiver's accounts for fees and disbursements, as set out in the Receiver's Third Report and other reports filed herein, together with any fees and disbursements related to the Receiver having to attend to the dispute related to the Remaining Funds, Allocation Matter and maintaining the receivership estate as set forth in Paragraph 3 above, are hereby approved without the necessity of a formal passing of its accounts.
7. The accounts of the Receiver's legal counsel, Torys LLP, for its fees and disbursements, as set out in the Receiver's Third Report and other reports filed herein, together with any fees and disbursements related to Torys LLP attending to the dispute related to the Remaining Funds, Allocation Matter and maintaining the receivership estate as set forth in Paragraph 3 above, are hereby approved without the necessity of a formal assessment of those accounts.
8. The Receiver is hereby authorized to pay any remaining professional fees up to the partial discharge of the Receiver, particulars of which are set out in the Third Report, together with the Professional Fees.
9. The Receiver's activities as set out in the Third Report and any other reports filed herein, and the Statement of Receipts and Disbursements as attached to the Third Report, are hereby ratified and approved.
10. On the evidence before the Court, the Receiver has satisfied its obligations under and pursuant to the terms of the Orders granted in the within proceedings up to and including the date hereof, and the Receiver shall not be liable for any act or omission on its part including, without limitation, any act or omission pertaining to the partial discharge of its duties in the within proceedings, save and except for any liability arising out of any fraud, gross negligence or willful misconduct on the part of the Receiver, or with leave of the Court. Subject to the foregoing any claims against the Receiver in connection with the performance of its duties are hereby stayed, extinguished and forever barred.
11. No action or other proceeding shall be commenced against the Receiver in any way arising from or related to its capacity or conduct as Receiver, except with prior leave of this Court on notice to the Receiver, and upon such terms as the Court may direct.
12. Upon the Receiver filing with the Clerk of the Court a discharge certificate (the "**Receiver's Discharge Certificate**") of a licensed insolvency trustee employed by the Receiver, in substantially the same form as attached as Schedule "B", confirming that:
 - (a) the matters set out in paragraphs 2 and 3 of this Order have been completed, the dispute over the Remaining Funds has been resolved, and the Allocation Matter has been dealt with; and

(b) all other minor administrative tasks required of the Receiver have been taken,

then the Receiver shall be fully and irrevocably discharged as Receiver of the Debtors, provided however, that notwithstanding its partial discharge herein (a) the Receiver shall remain Receiver for the performance of such incidental duties as may be required to complete the administration of the receivership herein, and (b) the Receiver shall continue to have the benefit of the provisions of all Orders made in this proceeding, including all approvals, protections and stays of proceedings in favour of the Receiver in its capacity as Receiver.

13. Prior to the Receiver's filing of the Discharge Certificate, the Receiver shall provide 14 days' notice to the NWT Receiver of its intention to file the Discharge Certificate.

MISCELLANEOUS

14. Nothing in this Order shall in any way affect the appointment, powers, obligations, liabilities or any thing whatsoever, of the NWT Receiver pursuant to the NWT Receivership Order. For greater certainty,
 - (a) the NWT Receiver shall remain the Court-appointed receiver over the NWT Property only (as defined in the NWT Receivership Order); and
 - (b) the stay of proceedings granted pursuant to paragraphs 12 and 13 of the NWT Receivership Order shall remain in place respecting each of the Debtors and the NWT Receiver.
15. Nothing in this Order shall in any way prejudice a party's rights in connection with the allocation of the funds (the "**Allocation Matter**") already spent pursuant to the Receivership Proceedings, which is still subject to further agreement between the parties and/or order of the Court. For certainty, nothing in this provision is intended to recover or regain any funds distributed to the Receiver for its, and its counsel's, fees and costs.
16. The Receiver is at liberty to reapply for further advice, assistance and direction as may be necessary to give full force and effect to, and in carrying out the terms of, this Order.
17. This Order must be served only upon those interested parties attending or represented at the within Application and service may be effected by facsimile, electronic mail, personal delivery or courier. Service is deemed to be effected the next business day following the transmission or delivery of such documents.
18. Service of this Order on any party not attending this Application is hereby dispensed with.
