# Backyard ReLaps 24HR Relay for the Mental Health Foundation!

The team of 4 will participate in a 24-hour relay race around a 6.7km trail track in Riverhead, West Auckland. Each team member will run the circuit every 4th rotation with a prediction of 65km per runner. Starting 9 AM Saturday 15 August and ending 9 AM Sunday (24 hours later), they will be putting their bodies through the maximum endurance and pain thresholds, running for a cause that is relevant to all of us.

Each team member has friends and family affected by mental health-related issues, so this is their effort to help those who need it most. By running this event they hope to raise funds by showing what a little bit of persistence and dependence on your mates can achieve.

#### Repairing Government Finances: Some taxing options?

COVID-19 has upended the economic and fiscal status quo. The Government is spending to protect the economy – that is understandable. This will, however, result in significant budget deficits and increase in net Crown debt. The choices about how we pay for that spend will need to be considered. The role of the tax system in repaying debt and repairing the Government's finances will no doubt feature in the upcoming election campaign.

#### Reporting News - COVID-19 Financial Reporting Impacts July 2020

KPMG's Accounting Advisory Services team outlined a number of financial reporting issues arising as a result of COVID-19 in our Reporting News – COVID-19 Edition released in March 2020. The New Zealand Government has since introduced a number of measures to assist businesses and other organisations in New Zealand. In particular, the wage subsidy and changes to tax deductibility of depreciation of certain properties raise several reporting issues for New Zealand entities. Our July COVID-19 update focuses on the accounting issues related to these NZ specific issues.
