

Authorized Economic Operator (AEO) status, granted by Ministry of Customs and Trade, is a privilege with international validity providing a certain number of means and benefits to reliable companies which meet their customs liabilities. have an organized and traceable record system, are in compliance with financial qualification, safety and security standards and are capable of self-assessment in

Who can become an Authorized Economic Operator (AEO)?



Any real and legal entity and state institution and organization resident and having operated in the Customs Territory of Turkey including Free Zones for at least three years can become an Authorized Economic.

AEO is an indicator of respectability which is valid not only in Turkey but also on international platforms. Privileges asserted 17, 250 also on international platforms. Privileges provided by AEO are also taken advantage of in jurisdictions with mutual recognition agreements.



By means of a privileged and quick service, both competitive advantage and cost reduction are provided




By becoming recognized as reliable in the market thanks to the AEO system, both national and international compatition system, both national and international competitive capacity increases in challenging market conditions.

AEO will be the only alternative to take advantage of means in customs procedures after the application for firms holding CAEO(certificate of Authorized Economic Operator) terminates.




What are the Means of an AEO?
















Means utilizable by AEOs depending on requests and additional conditions
